### Supplement to the Registration Document dated 30 May 2012

#### AMENDMENTS OR ADDITIONS TO THE REGISTRATION DOCUMENT

On 28 June 2012 ABN AMRO published a press release titled "ABN AMRO and Ageas agree to settle legal proceedings". A copy of the press release has been filed with the Netherlands Authority for the Financial Markets (*Autoriteit Financiële Markten*). By virtue of this Supplement, the press release is incorporated in, and forms part of, the Registration Document.

With effect from the date of this Supplement the information appearing in, or incorporated by reference into, the Registration Document shall be amended and/or supplemented in the manner described below. References to page numbers are to the pages of the Registration Document.

- 1. In Section 3 *Incorporation by reference*, on page 19 of the Registration Document, the following new paragraph (h) shall be inserted (with deletion of "and" at the end of paragraph (f) and replacement of "." at the end of paragraph (g) with "; and"):
  - "(h) the press release titled "ABN AMRO and Ageas agree to settle legal proceedings" dated 28 June 2012. The information set out therein in unaudited.".
- 2. In Section 7 *Trend Information*, on page 72, subsection 7.1 (Legal and arbitration proceedings), the last paragraph shall be replaced with the following wording:

"In addition, the Issuer is involved in a number of governmental, legal and arbitration proceedings in the ordinary course of its business in a number of jurisdictions. However, on the basis of information currently available, and having taken legal counsel with advisors, the Issuer is of the opinion that it is not, nor has it been, involved in any governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which the Issuer is aware) during the 12 months preceding the date of this Registration Document which may have, or have had in the recent past, significant effects on the consolidated financial position or consolidated profitability of the Issuer and/or its subsidiaries, other than as set out in the press release titled "ABN AMRO and Ageas agree to settle legal proceedings" dated 28 June 2012, which press release is incorporated by reference in this Registration Document.".

3. In Section 7 *Trend Information*, on page 74, subsection 7.6 (Changes in prospects or financial position) shall be replaced with the following wording:

# "7.6 Changes in prospects or financial position

There has been no material adverse change in the Issuer's prospects since 31 December 2011.

There have been no significant changes in the financial position of the Issuer and its subsidiaries since 31 December 2011, other than as set out in the press release titled "ABN AMRO and Ageas agree to settle legal proceedings" dated 28 June 2012, which press release is incorporated by reference in this Registration Document.

There has been no material adverse change in ABN AMRO Group's prospects since 31 December 2011.

There have been no significant changes in the financial position of ABN AMRO Group and its subsidiaries since 31 December 2011, other than as set out in the press release titled "ABN AMRO and Ageas agree to settle legal proceedings" dated 28 June 2012, which press release is incorporated by reference in this Registration Document."

4. In Section 9 *General Information*, on page 80, the subsection titled "Significant Change" shall be replaced with the following wording:

### "Significant change

There has been (i) no material adverse change in the Issuer's prospects or (ii) significant change in the financial position of the Issuer and its subsidiaries since 31 December 2011, other than as set out in the press release titled "ABN AMRO and Ageas agree to settle legal proceedings" dated 28 June 2012, which press release is incorporated by reference in this Registration Document.".

5. In Section 9 *General Information*, on page 80, the subsection titled "Litigation" shall be replaced with the following wording:

# "Litigation

There are no governmental, legal or arbitration proceedings, (including any such proceedings which are pending or threatened, of which the Issuer is aware), which may have, or have had during the 12 months prior to the date of this Registration Document, a significant effect on the financial position or profitability of the Group and/or the Issuer and its subsidiaries, other than as set out in the press release titled "ABN AMRO and Ageas agree to settle legal proceedings" dated 28 June 2012, which press release is incorporated by reference in this Registration Document.".
