**FOURTH SUPPLEMENT TO THE BASE PROSPECTUS IN RESPECT OF THE €35,000,000,000
RESIDENTIAL MORTGAGE BACKED SECURED DEBT ISSUANCE PROGRAMME**

Residential Mortgage Backed Secured Debt Issuance Programme

1. This Supplement dated 8 July 2009 (the **Supplement**) constitutes the fourth supplement to the base prospectus dated 27 March 2009 in relation to the Residential Mortgage Backed Secured Debt Issuance Programme established by European Mortgage Securities VII B.V. (the **Issuer**) approved by the Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the **AFM**) on 27 March 2009, as supplemented on 30 March 2009, 8 April 2009 and 28 May 2009 (hereinafter referred to as the **Base Prospectus**). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.
2. The Base Prospectus was approved as a base prospectus pursuant to the Directive 2003/71/EC by the AFM. This Supplement constitutes a supplemental prospectus to the Base Prospectus for the purposes of Article 5:23 of the Financial Supervision Act (*Wet op het financieel toezicht*).
3. This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus and any other supplements thereto issued by the Issuer.
4. The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (having taken all reasonable care to ensure that such is the case), the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.
5. By means of this Supplement, the Registration Document dated 30 June 2009 of ABN AMRO Holding N.V. (**Holding**) and ABN AMRO Bank N.V. (the **Registration Document**) as supplemented by a supplement dated 8 July 2009, which has been published after publication of the Base Prospectus and approved by and filed with the AFM, shall be deemed to be incorporated in, and to form part of, the Base Prospectus. The Registration Document replaces the registration document dated 27 June 2008 and the supplements thereto currently referred to and incorporated by reference in the Base Prospectus.
6. On 2 July 2009, ABN AMRO Group issued a press release regarding an update on capital actions (the **Press Release**).
7. A copy of the Press Release has been filed with the AFM and, by virtue of this Supplement, the Press Release is incorporated into, and forms part of, the Base Prospectus.

8. Copies of all documents incorporated by reference in the Base Prospectus can be obtained, on request, free of charge, by writing to, or telephoning, the Issuer, Frederik Roeskestraat 123, 1076 EE Amsterdam, or the Paying Agent, Kemelstede 2, 4817 ST Breda.
9. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.
10. Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus since its publication.
11. In accordance with Article 5:23(6) of the Financial Supervision Act (*Wet op het financieel toezicht*), investors who have agreed to purchase or subscribe for Notes before the Supplement is published have the right, exercisable before the end of the period of two working days beginning with the working day after the date on which this Supplement was published, to withdraw their acceptances.
