**Supplement to the Base Prospectus dated 5 July 2018**

This supplement (the "**Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with, the base prospectus dated 5 July 2018 issued by ABN AMRO Bank N.V., as supplemented by the first supplement dated 17 August 2018, the second supplement dated 8 November 2018 and the third supplement dated 14 February 2019 (the "**Base Prospectus**"). The Base Prospectus has been issued by ABN AMRO Bank N.V. in respect of a Programme for the Issuance of Medium Term Notes. This Supplement, together with the Base Prospectus, constitutes a base prospectus for the purposes of Article 5.4 of Directive 2003/71/EC of the European Parliament and of the Council (as amended or superseded, the "**Prospectus Directive**"). Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in or incorporated by reference into the Base Prospectus, the statements in (a) above will prevail.

## AMENDMENTS OR ADDITIONS TO THE BASE PROSPECTUS

On 14 March 2019 ABN AMRO Bank N.V. published a fourth supplement to the registration document of ABN AMRO Bank N.V. dated 5 July 2018 (the "**Registration Document**"). A copy of the fourth supplement to the Registration Document has been filed with the Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*) and, by virtue of this Supplement, the fourth supplement to the Registration Document is incorporated in, and forms part of, the Base Prospectus.
