This Base Prospectus supplement (the 'Base Prospectus Supplement') constitutes a base prospectus supplement for the purposes of Directive 2003/71/EC, as amended (the 'Prospectus Directive') and the Dutch Financial Supervision Act (Wet op het financiael toezicht) and regulations thereunder (together, 'Dutch securities laws') and is prepared in connection with the Global Medium-Term Note Programme (the 'Programme') under which Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (Rabobank Nederland) ('Rabobank Nederland', the 'Bank' or the 'Issuer'), may through its head office or through its branches listed above, subject to compliance with all relevant laws, regulations and directives, from time to time issue Global Medium-Term Notes (the 'Notes'). References herein to the 'Issuer' shall mean Rabobank Nederland, whether issuing Notes through its head office or through its branches listed above.

The branches through which Rabobank Nederland may issue Notes are Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (Rabobank Nederland) Australia Branch and Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (Rabobank Nederland) Singapore Branch.

This Base Prospectus Supplement is supplemental to, and should be read in conjunction with, the base prospectus dated 8 May 2013 and the base prospectus supplement dated 22 August 2013 (the 'First Base Prospectus Supplement') and the base prospectus supplement dated 29 October 2013 (the 'Second Base Prospectus Supplement') (the First Base Prospectus Supplement and the Second Base Prospectus Supplement, together with the base prospectus dated 8 May 2013, the 'Base Prospectus'). Capitalised terms used but not otherwise defined in this Base Prospectus Supplement shall have the meanings ascribed thereto in the Base Prospectus. To the extent that there is any inconsistency between (a) any statement in this Base Prospectus Supplement or any statement incorporated by reference into the Base Prospectus by this Base Prospectus Supplement and (b) any other statement in or incorporated by reference into the Base Prospectus, the statements in (a) will prevail.

Save as disclosed in this Base Prospectus Supplement, no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus has arisen or been noted, as the case may be, since the publication of the Base Prospectus.

This Base Prospectus Supplement has been submitted to and approved by the Netherlands Authority for the Financial Markets (*Autoriteit Financiële Markten*) in its capacity as competent authority under the Prospectus Directive and Dutch securities laws.

In accordance with Article 5:23(6) of the Dutch Financial Supervision Act (*Wet op het financieel toezicht*), investors who have agreed to purchase or subscribe for Notes issued under the EUR 160,000,000,000 Global Medium-Term Note Programme before the Base Prospectus Supplement is published have the right, exercisable before the end of the period of two business days beginning with the business day after the date on which this Base Prospectus Supplement was published, to withdraw their acceptances.

shall be replaced with the sentence:

"Senior long-term Notes issued under the Programme by Rabobank Nederland and Rabobank Singapore Branch are expected to be rated AA- by Fitch Ratings Limited ("Fitch") and Senior long term Notes issued under the Programme by Rabobank Australia Branch are expected to be rated AA- by Fitch Australia Pty Ltd. ("Fitch Australia")."

On page 13 in part 'B.3' of the section entitled 'Section B – Issuer' in the chapter 'Summary of the Programme relating to PD Notes'

The sentence:

"Senior long-term Notes issued under the Programme by Rabobank Nederland and Rabobank Singapore Branch are expected to be rated AA by Fitch and Senior long-term Notes issued under the Programme by Rabobank Australia Branch are expected to be rated AA by Fitch Australia."

shall be replaced with the sentence:

"Senior long-term Notes issued under the Programme by Rabobank Nederland and Rabobank Singapore Branch are expected to be rated AA- by Fitch and Senior long-term Notes issued under the Programme by Rabobank Australia Branch are expected to be rated AA- by Fitch Australia."

On pages 55 and 56 in the section entitled 'Rating' in the chapter 'General Description of the Programme'

The sentences:

"Senior long term Notes issued under the Programme by Rabobank Nederland and Rabobank Singapore Branch are expected to be rated AA by Fitch and Senior long-term Notes issued under the Programme by Rabobank Australia Branch are expected to be rated AA by Fitch Australia."

and

"As defined by Fitch, an 'AA' rating means that the Notes are judged to be of a very high credit quality and denotes expectations of very low default risk. It indicates very strong capacity for payment of financial commitments and is not significantly vulnerable to foreseeable events."

shall respectively be replaced with the sentences:

"Senior long term Notes issued under the Programme by Rabobank Nederland and Rabobank Singapore Branch are expected to be rated AA- by Fitch and Senior long-term Notes issued under the Programme by Rabobank Australia Branch are expected to be rated AA- by Fitch Australia."

and

"As defined by Fitch, an 'AA' rating means that the Notes are judged to be of a very high credit quality and denotes expectations of very low default risk. It indicates very strong capacity for payment of financial commitments and is not significantly vulnerable to foreseeable events. The modifier "-" is appended to denote relative status within the rating category."

On page 158 under 'Ratings' at the end of the sub-section entitled 'Recent Developments' of the chapter 'Description of Business of the Rabobank Group'

The following sentence shall be inserted at the end of the final paragraph in such sub-section:

"On 22 November 2013, Fitch lowered the long-term IDR of Rabobank Group to 'AA-' from 'AA'. The outlook on this rating remains negative."
