This Base Prospectus supplement (the 'Base Prospectus Supplement') constitutes a base prospectus supplement for the purposes of Directive 2003/71/EC (the 'Prospectus Directive') and the Dutch Financial Supervision Act (*Wet op het financiael toezicht*) and regulations thereunder (together, 'Dutch securities laws') and is prepared in connection with the German Debt Issuance Programme (the 'Programme') under which Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (Rabobank Structured Products) ('Rabobank Structured Products', the 'Bank' or the 'Issuer'), may, subject to compliance with all relevant laws, regulations and directives, from time to time issue notes, including (but not limited to) Equity Linked Notes, Index Linked Notes, Dual Currency Notes, Partly-Paid Notes, Fixed Rate Notes or Floating Rate Notes (the 'Notes').

This Base Prospectus Supplement is supplemental to, and should be read in conjunction with, the base prospectus dated 12 June 2012, the base prospectus supplement dated 15 June 2012 (the 'First Base Prospectus Supplement'), the base prospectus supplement dated 23 August 2012 (the 'Second Base Prospectus Supplement') and the base prospectus supplement dated 19 November 2012 (the 'Third Base Prospectus Supplement') (the First Base Prospectus Supplement, the Second Base Prospectus Supplement and the Third Base Prospectus Supplement, together with the base prospectus dated 12 June 2012, the 'Base Prospectus'). Capitalised terms used but not otherwise defined in this Base Prospectus Supplement in this Base Prospectus Supplement or any statement incorporated by reference into the Base Prospectus by this Base Prospectus Supplement and (b) any other statement in or incorporated by reference into the Base Prospectus, the statements in (a) will prevail.

Save as disclosed in this Base Prospectus Supplement, no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus has arisen or been noted, as the case may be, since the publication of the Second Base Prospectus Supplement.

This Base Prospectus Supplement has been submitted to and approved by the Netherlands Authority for the Financial Markets (*Autoriteit Financiële Markten*) in its capacity as competent authority under the Prospectus Directive and Dutch securities laws.

In accordance with Article 5:23(6) of the Dutch Financial Supervision Act (*Wet op het financieel toezicht*), investors who have agreed to purchase or subscribe for Notes issued under the Programme before the Base Prospectus Supplement is published have the right, exercisable before the end of the period of two business days beginning with the business day after the date on which this Base Prospectus Supplement was published, to withdraw their acceptances.

On page 25 of the Base Prospectus, the wording under sub-paragraphs (e) and (f) shall be deleted and replaced with the following:

- "(e) the most recent articles of association of the Issuer;
- (f) the interim report of Rabobank Group for the six months ended 30 June 2012 containing the condensed consolidated interim financial information of Rabobank Group for the six months ended 30 June 2012;
- (g) the Annual Summary 2012 of Rabobank Group; and
- (h) the press release dated 28 February 2013 in relation to the Annual Summary of Rabobank Group for the year ended 31 December 2012."
