

## THIRD SUPPLEMENT

### TO THE BASE PROSPECTUS DATED 14 OCTOBER 2022

#### DE VOLKSBANK N.V.

(incorporated under Dutch law as a public company with limited liability and having its corporate seat in Utrecht, the Netherlands)

Under its € 25,000,000,000 Debt Issuance Programme (the “**Programme**”) de Volksbank N.V. (the “**Issuer**” or “**de Volksbank**”) may from time to time issue Senior Preferred Notes, Senior Non-Preferred Notes or Subordinated Notes (the “**Notes**”) denominated in any currency agreed between the Issuer and the relevant Dealer, if any.

This supplement (the “**Supplement**”) is based on Article 23 of Regulation (EU) 2017/1129, including any commission delegated regulation thereunder (the “**Prospectus Regulation**”) and constitutes the third supplement to the base prospectus dated 14 October 2022 of de Volksbank N.V. supplemented by the first supplement dated 15 February 2023 and the second supplement dated 21 March 2023 (the “**Base Prospectus**”) in respect of non-equity securities and is prepared to update and amend the Base Prospectus, and is supplemental to, forms part of and should be read in conjunction with the Base Prospectus. Terms defined in the Base Prospectus shall have the same meaning in this Supplement, unless specified otherwise.

This Supplement has been approved by the Dutch Authority for the Financial Markets (“**Stichting Autoriteit Financiële Markten**”, the “**AFM**”), as competent authority under the Prospectus Regulation for the purpose of giving information with regard to the issue of Notes under the Programme during the period of twelve months after the date of the Base Prospectus.

The Issuer has requested the AFM to provide the competent authority in Luxembourg with a certificate of approval (the “**Notification**”) attesting that this Supplement has been drawn up in accordance with the Prospectus Regulation.

An investment in the Notes involves certain risks. Prospective investors should have regard to the risk factors described under chapter 1.1 'Risk Factors' in the Base Prospectus.

This Supplement is supplemental to, forms part of, and must be read and construed together with the Base Prospectus and with the documents incorporated by reference therein (which can be found on the website of the Issuer, <https://www.devолksbank.nl/en/investor-relations/debt-information/unsecured-funding/euro-medium-term-notes>, and may be obtained by contacting the Issuer by telephone (+31 30 291 42 46/ + 31 30 291 48 07) or by email: jacob.bosscha@devолksbank.nl and davey.hak@devолksbank.nl), and in relation to any Tranche, the Base Prospectus and this Supplement should be read and construed together with the applicable Final Terms.

The delivery of the Base Prospectus (as supplemented by this Supplement) or any Final Terms and the offering, sale or delivery of any Notes shall not in any circumstances imply that the information contained in such documents is correct at any time subsequent to their respective dates of issue or that there has been no adverse change in the financial situation of the Issuer since such date or that any other information supplied in connection with the Programme or the Notes is correct at any time subsequent to the date on which it is supplied or, if different, the time indicated in the document containing the same. Terms used in this paragraph have the meanings given to them by the U.S. Internal Revenue Code and regulations thereunder.

Interest and/or other amounts payable under the Notes may be calculated by reference to certain reference rates. Any such reference rate may constitute a benchmark under the EU regulation on indices used as benchmarks in financial instruments and financial contracts or to measure the performance of investment funds (EU 2016/1011) (“**EU Benchmarks Regulation**”). If any such reference rate does constitute such a benchmark, the applicable Final Terms will indicate whether or not the administrator thereof is included in the register of administrators and benchmarks established and maintained by the European Securities and Markets Authority (“**ESMA**”) pursuant to Article 36 (Register of administrators and benchmarks) of the EU Benchmarks Regulation. Not every reference rate will fall within the scope of the EU Benchmarks Regulation. Furthermore, transitional provisions in the Benchmark Regulation may have the result that an administrator and/or a benchmark is not required to appear in the register of administrators and benchmarks at the date of the applicable Final Terms. The registration status of any administrator or benchmark under the EU Benchmarks Regulation is a matter of public record and, save where required by applicable law, the Issuer does not intend to update any Final Terms to reflect any change in the registration status of the administrator.

Neither the Base Prospectus and this Supplement nor any other information supplied in connection with the Programme should be considered as a recommendation by the Issuer, the Arranger or any Dealer that any recipient of the Base Prospectus and this Supplement or any other information supplied in connection with the Programme should purchase any Notes. Accordingly, no representation, warranty or undertaking, express or implied, is made by the Arranger or any Dealer in their capacity as such. Neither the Issuer nor any Dealer have authorised, nor do they authorise, the making of any offer of Notes in circumstances in which an obligation arises for the Issuer or any Dealer to publish or supplement a prospectus for such offer.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any statement incorporated by reference into the Base Prospectus, including any prior supplement to the Base Prospectus, the statements under (a) above will prevail.

## MODIFICATIONS TO THE BASE PROSPECTUS

The following are amendments to the Base Prospectus.

References to page numbers are to page numbers of the Base Prospectus (unless stated otherwise below).

1. On page 89 in chapter 1.10 under the heading “**DOCUMENTS INCORPORATED BY REFERENCE**”, the following document shall be added to the list of documents incorporated in and to form part of, the Base Prospectus (with the deletion of “and” at the end of paragraph (n) and replacement of “.” at the end of paragraph (o) with “; and”):

(p) The (i) interim financial report 2023 and the (ii) press release published by the Issuer on 11 August 2023 regarding the Issuer’s results for the first half of 2023, which can be respectively obtained from <https://newsroom.devolksbank.nl/download/c456affa-b6ba-4d2d-86cb-7c45c5a47ee8/interimfinancialreport2023.pdf> and <https://newsroom.devolksbank.nl/download/4d0cfd47-af6e-4968-b622-82165d8753b9/persbericht-1hj23resultaten.pdf>.

2. On page 59 chapter 1.3 with the heading “Green Senior Non-Preferred Notes Issue”, will be replaced in its entirety by:

*“Green Senior Non-Preferred Notes issuances*

On 7 March 2023, the Issuer successfully issued € 500 million of Senior Non-Preferred Notes. The Senior Non-Preferred Notes have a term of seven years and a coupon of 4.875%. On 23 May 2023 the Issuer successfully issued € 500 million of Senior Non-Preferred Notes. The Senior Non-Preferred Notes have a term of four and a half years and a coupon of 4.625%. These are the Issuer’s fourth and fifth issuances of Senior Non-Preferred Notes, following three issuances of € 500 million in 2021 and 2022.”

3. On pages 61-62 in chapter 1.3 under the heading “Recent Developments”, paragraph “*Profit forecast*” will be replaced in its entirety by:

*“Profit Forecast*

On 11 August 2023, the Issuer published its interim financial report 2023 regarding the Issuer’s results for the first half of 2023, which includes the following profit forecast:

“Taking into account the factors described above, we expect net profit for 2023 to be substantially above that of 2022.”

The Issuer expects its net profit for the full year 2023 to be substantially above that of 2022, mainly due to:

1. The expected net interest income that will continue to benefit from the current favourable interest rate environment, although this is highly dependent on the ECB interest rate policy; and
2. The expected low level of additional impairment charges on loans and advances in the second half of 2023.

This forecast is comparable with the Issuer's historical financial information and consistent with its current accounting policies. The profit forecast has been prepared on the basis of certain (internal and external) assumptions, including the principal assumptions as set out below.

The principal assumptions upon which the Issuer bases its forecast and that the Issuer can influence are as follows:

- (a) factors that influence net interest income: (i) continuation of current pricing strategy on mortgages and (ii) a conservative savings rate strategy;
- (b) no significant interruption in operational performance and programme execution;
- (c) continued investments in our IT foundation and projects related to banking regulation and customer integrity; and
- (d) no disruption in or change to the development of products.

The principal assumptions upon which the Issuer bases its forecast and that are exclusively outside the influence of the Issuer are as follows:

- (a) no worsened general trading conditions, economic conditions or competitive environment which would materially affect the Issuer's business;
- (b) no material change in the ability or willingness of the Issuer's customers to meet their contractual obligations, including payment obligations to the Issuer; and
- (c) no changes in the legislative or regulatory environment which could have a material effect on the Issuer.

Notwithstanding the above mentioned press release and the assumptions above, the actual net profit for the full year 2023 may deviate from expectations stipulated therein."
