## Supplement to the Base Prospectus dated 6 December 2013

This supplement (the "**Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with, the base prospectus dated 6 December 2013, as supplemented by the first supplement dated 24 February 2014, the second supplement dated 11 March 2014, the third supplement dated 7 April 2014, the fourth supplement dated 19 May 2014, the fifth supplement dated 19 June 2014 and the sixth supplement dated 4 July 2014 (the "**Base Prospectus**"). The Base Prospectus has been issued by ABN AMRO Bank N.V. (the "**Issuer**") in respect of a €30,000,000,000 Covered Bond Programme (the "**Programme**"). This Supplement, together with the Base Prospectus, constitutes a base prospectus for the purposes of Article 5.4 of Directive 2003/71/EC of the European Parliament and of the Council (as amended, the "**Prospectus Directive**"). Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in or incorporated by reference into the Base Prospectus, the statements in (a) above will prevail.

The Issuer and the CBC accept responsibility for the information contained in this Supplement and declare that, having taken all reasonable care to ensure that such is the case, such information is, to the best of their knowledge, in accordance with the facts and contains no omission likely to affect its import.

Bearer Covered Bonds are in bearer form and are therefore subject to U.S. tax law requirements. Subject to certain exceptions, the Covered Bonds may not be offered, sold or delivered within the United States or to, or for the account or benefit of, U.S. persons.

So long as the Base Prospectus and this Supplement are valid as described in Article 9 of the Prospectus Directive, copies of this Supplement and the Base Prospectus, together with the other documents listed in *Section D.1 Incorporation by Reference* of the base prospectus dated 6 December 2013 will be available, free of charge, during usual business hours on any weekday (Saturdays, Sundays and public holidays excepted) from the registered office of the Issuer at Gustav Mahlerlaan 10, 1082 PP Amsterdam, The Netherlands and from the specified office of the Listing Agent and the Principal Paying Agent.

## AMENDMENTS OR ADDITIONS TO THE BASE PROSPECTUS

On 25 August 2014 ABN AMRO Bank N.V. published a first supplement to the registration document of ABN AMRO Bank N.V. dated 27 June 2014 (the "**Registration Document**"). A copy of the first supplement to the Registration Document has been filed with the Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*) and, by virtue of this Supplement, the Registration Document and the first supplement to the Registration Document are incorporated in, and form part of, the Base Prospectus.

With effect from the date of this Supplement the information appearing in, or incorporated by reference into, the Base Prospectus shall be amended and/or supplemented in the manner described below. References to page numbers are to the pages of the base prospectus dated 6 December 2013.

- 1. In *Section D.1 Incorporation by Reference*, on page 77, paragraph (a) shall be replaced with the following wording:
  - "(a) the registration document of the Issuer dated 27 June 2014 (the "**Registration Document**"), as supplemented by a first supplement dated 25 August 2014;".
- 2. In *Section D.1 Incorporation by Reference*, on page 79, the following new paragraphs (ee) and (ff) shall be inserted (with the deletion of "and" at the end of paragraph (cc) and replacement of "," at the end of paragraph (dd) with ";":
  - "(ee) ABN AMRO Group N.V.'s publicly available reviewed condensed consolidated interim financial statements for the first half of the financial year ended 30 June 2014 (the "**Interim Financial Statements 2014**", as set out on pages 68 through 74 in relation to the Interim Financial Statements 2014, including the notes thereto as set out on pages 75 through 102, the information marked as reviewed in Chapter 7 (*Risk management*) on pages 32 to 54, the auditors' review report on page 103 and the Section "*Notes to the reader*" in the inside cover, all as included in ABN AMRO Group N.V.'s Interim Financial Report 2014); and
  - (ff) Chapter 1 (Figures at a glance), Chapter 2 (Chairman of the Managing Board's message), Chapter 3 (Economic environment), Chapter 4 (Operating and financial review), Chapter 5 (Results by segment), Chapter 6 (Additional financial information), Chapter 7 (Risk management), Chapter 8 (Capital management), Chapter 9 (Liquidity & funding) and Chapter 11 (Enquiries) of the Interim Financial Report 2014,".
