ABN AMRO Covered Bond Programme

- 1. This Supplement dated 27 November 2009 (the **Supplement**) constitutes the sixth supplement to the base prospectus dated 15 May 2009 (the **Base Prospectus**) in relation to the EUR 25,000,000,000 Covered Bond Programme (the **Programme**) established by ABN AMRO Bank N.V. (the **Issuer**) and approved by the Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the **AFM**) on 15 May 2009, as supplemented on 28 May 2009, 8 July 2009, 11 August 2009, 28 August 2009 and 19 October 2009. Terms defined in the Base Prospectus have the same meaning when used in this Supplement.
- 2. The Base Prospectus was approved as a base prospectus pursuant to Directive 2003/71/EC by the AFM. This Supplement constitutes a supplemental prospectus to the Base Prospectus for the purposes of Article 5:23 of the Financial Supervision Act (*Wet op het financial toezicht*).
- 3. This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus and any other supplements thereto issued by the Issuer.
- 4. The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (having taken all reasonable care to ensure that such is the case), the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.
- 5. On 25 November 2009, ABN AMRO Holding N.V issued a press release reporting its third quarter financial results for the 3 months ended 30 September 2009 (the **Press Release**).
- 6. A copy of the Press Release has been filed with the AFM and, by virtue of this Supplement, the Press Release is incorporated into, and forms part of, the Base Prospectus.

In accordance with Article 5:23(6) of the Financial Supervision Act (*Wet op het financieel toezicht*), investors who have agreed to purchase or subscribe for Covered Bonds issued under the Programme before the Supplement is published have the right, exercisable before the end of the period of two working days beginning with the working day after the date on which this Supplement was published, to withdraw their acceptances.
