This Supplement (the “**Supplement**”) is prepared as a supplement to, and must be read in conjunction with, the Registration Document dated 27 June 2016, as supplemented by the supplements dated 4 August 2016, 4 November 2016 and 3 February 2017, issued by ING Bank N.V., Sydney Branch (the “**Registration Document**”). This Supplement, together with the Registration Document, constitutes a registration document for the purposes of Article 5.4 of Directive 2003/71/EC of the European Parliament and of the Council, as amended, to the extent that such amendments have been implemented in the relevant Member State of the European Economic Area (the “**Prospectus Directive**”). Terms used but not defined in this Supplement have the meanings ascribed to them in the Registration Document. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Registration Document by this Supplement and (b) any other statement in or incorporated by reference in the Registration Document, the statements in (a) above will prevail. ING Bank N.V., Sydney Branch (the “**Issuer**” or “**ING Sydney Branch**”) accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

No person has been authorised to give any information or to make any representation not contained in or not consistent with the Registration Document and this Supplement and, if given or made, such information or representation must not be relied upon as having been authorised by the Issuer.

Neither the delivery of this Supplement nor the Registration Document shall in any circumstances imply that the information contained in the Registration Document and herein concerning the Issuer is correct at any time subsequent to the date of the Registration Document (in the case of the Registration Document) or the date hereof (in the case of this Supplement).

RECENT DEVELOPMENTS AND INFORMATION INCORPORATED BY REFERENCE

On 16 May 2017, ING Bank N.V. (including the Issuer) published an updated registration document, a copy of which has been approved by and filed with the AFM and, by virtue of this Supplement, is incorporated by reference in, and forms part of, the Registration Document.

MODIFICATIONS TO THE REGISTRATION DOCUMENT

1. *Item (b) of the section entitled “Documents Incorporated by Reference” on page 4 of the Registration Document shall be deleted and restated as follows:*

“(b) the registration document of ING Bank N.V. (including the Issuer) dated 16 May 2017, prepared in accordance with Article 5 of the Prospectus Directive and approved by the AFM (the “**ING Bank N.V. Registration Document**”), including, for the purpose of clarity, the following items incorporated by reference therein:

- (i) the Articles of Association (*statuten*) of ING Bank N.V. (including the Issuer);
- (ii) the publicly available annual reports of ING Bank N.V. (including the Issuer) in respect of the years ended 31 December 2014, 2015 and 2016, including the audited financial statements and auditors' reports in respect of such years;
- (iii) the press release published by ING Group on 25 April 2017 entitled “ING to participate in Bank of Beijing share offering”; and
- (iv) the press release published by ING Groep N.V. (“**ING Group**”) on 10 May 2017 entitled “ING 1Q17 net result EUR 1,143 million” (the “**Q1 Press Release**”). The Q1 Press Release contains, among other things, the consolidated unaudited interim results of ING Group as at, and for the three month period ended, 31 March 2017, as well as information about recent developments during this period in the banking business of ING Group, which is conducted substantially through ING Bank N.V. (including the Issuer) and its consolidated group.”.

2. *The penultimate paragraph in the section entitled “Documents Incorporated by Reference” on page 4 of the Registration Document shall be deleted and restated as follows:*

“With respect to the Q1 Press Release, prospective investors should note that ING Bank N.V.’s (including the Issuer’s) consolidated operations, while materially the same, are not identical with the reported financial and statistical information on a segment basis for the banking business of ING Group as described in the Q1 Press Release. ING Group is not responsible for the preparation of this Registration Document.”.

3. *Item (ii) of the section entitled “General Information - Documents Available for Inspection or Collection” on page 7 of the Registration Document shall be deleted and restated as follows:*

“(ii) the publicly available annual reports of ING Bank N.V. (including the Issuer) in respect of the years ended 31 December 2014, 2015 and 2016 including the audited financial statements and the auditors' reports in respect of such years;”.

4. The section entitled “General Information - Significant or Material Adverse Change” on page 7 of the Registration Document shall be deleted and restated as follows:

“For information regarding any significant change in the financial or trading position of ING Bank N.V. (including the Issuer) and its consolidated subsidiaries since 31 December 2016 and any material adverse change in the prospects of ING Bank N.V. (including the Issuer) since 31 December 2016, see the section of the ING Bank N.V. Registration Document headed “General Information - Significant or Material Adverse Change”.
