#### **General Information**

-Paragraph **6. Legal and Arbitration Proceedings** in section entitled "**GENERAL INFORMATION**" appearing on page 597 of the Base Prospectus is hereby deleted and shall be amended as follows:

"Save as disclosed on page 86 of the Information Statement (*Legal proceedings*) and on page 144 of the Second Update to the 2011 Registration Document (*Legal and arbitration proceedings*), there have been no governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which either Issuer is aware), during the period covering at least the 12 months prior to the date of this Supplement which may have, or have had in the recent past, significant effects on either Issuer and/or the Group's financial position or profitability".

-Paragraph **7. Significant Change** in section entitled "**GENERAL INFORMATION**" appearing on page **5**97 of the Base Prospectus shall be amended as follows:

## 7. Significant Change

The first sentence "There has been no significant change in the financial or trading position of the Group since 31 December 2011 being the end of the last financial period for which audited financial statements have been published" shall be deleted in its entirety and replaced by the following sentence:

"There has been no significant change in the financial or trading position of the Group since 30 June 2012 being the end of the last financial period for which interim financial information has been published"

In accordance with Article 16.2 of the Prospectus Directive, in the case of a public offer of Securities, investors who have already agreed to purchase or subscribe Warrants or Certificates pursuant to the Programme before this Supplement is published have the right, exercisable within two working days after the publication of this Supplement, to withdraw their acceptances.
