This Supplemental Summary Note (the “**Summary Note**”) is supplemental to the summary note dated 19 March 2009 in connection with the Notes (as defined below) and has been prepared due to the publication on 2 April 2009 of a Supplement (as defined below) and the amendment of the “Description of the Issuer” section of this Summary Note. The Supplement is available free of charge by request from the Issuer. Written or oral requests for such document should be directed to the Issuer at the address specified below. No changes have been made to the “Description of the Notes” section of this Summary Note following the publication of the Supplement. This Summary Note has been prepared in connection with the issue by ING Bank N.V. (the “**Issuer**”) of EUR 8,000,000 4 Year Sprint Oil Notes due April 2013 (the “**Notes**”) under its €80,000,000,000 Global Issuance Programme (the “**Programme**”).

This Summary Note constitutes a summary note and, together with the Registration Document and the Securities Note (each as defined below), a prospectus (the “**Prospectus**”) for the purposes of Article 5 of Directive 2003/71/EC (the “**Prospectus Directive**”) for the purpose of giving information with regard to the Issuer and the Notes which, according to the particular nature of the Issuer and the Notes, is necessary to enable investors to make an informed assessment of the assets and liabilities, financial position, profit and losses and prospects of the Issuer and of the rights attached to the Notes.

The Issuer accepts responsibility for the information contained in this Summary Note. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case), the information contained in this Summary Note, when read together with the Registration Document and the Securities Note, is in accordance with the facts and does not omit anything likely to affect the import of such information.

On 15 September 2008, the Issuer published a Base Prospectus (the “**Original Base Prospectus**”) in respect of the Programme. On 28 October 2008, 13 November 2008, 1 December 2008, 27 January 2009, 30 January 2009, 19 February 2009 and 2 April 2009 respectively, the Issuer published Supplements to the Original Base Prospectus (the “**Supplements**”, each a “**Supplement**” and, together with the Original Base Prospectus, the “**Base Prospectus**”). On 15 September 2008, the Issuer published a Registration Document (the “**Registration Document**”). On the date hereof, the Issuer published a Supplemental Securities Note in respect of the issue of the Notes (the “**Securities Note**”). This Summary Note should be read and construed in conjunction with the Securities Note (which incorporates by reference certain sections of Chapter 1 of the Original Base Prospectus and the Supplements as described in the Securities Note) and the Registration Document (which incorporates by reference Chapter 1 of the Original Base Prospectus and the details of relevant parties to the Programme on the last five pages of the Original Base Prospectus (the “**List of Parties**”). This Summary Note and the Securities Note have each been filed with, and approved by, the *Autoriteit Financiële Markten* (the “**AFM**”) in its capacity as competent authority under the *Wet op het financieel toezicht* (Dutch Financial Supervision Act). The Original Base Prospectus was filed with the AFM and approved by it on 15 September 2008. The Supplements were filed with the AFM and approved by it on 28 October 2008, 13 November 2008, 1 December 2008, 27 January 2009, 30 January 2009, 19 February 2009 and 2 April 2009 respectively. The Registration Document was filed with the AFM and approved by it on 15 September 2008. Terms used but not defined herein shall have the meanings given to them in the Securities Note.

DESCRIPTION OF THE ISSUER

ING Bank N.V. is part of ING Groep N.V., also called ING Group. ING Group is the holding company of a broad spectrum of companies (together called “ING”), offering banking, investments, life insurance and retirement services to about 85 million private, corporate and institutional clients in Europe, the United States, Canada, Latin America, Asia and Australia. Originating from The Netherlands, ING has a workforce of almost 125,000 people worldwide. ING Group holds all shares of ING Bank N.V., which is a non-listed 100% subsidiary of ING Group.

ING Bank N.V. (ING Bank) is represented in more than 40 countries around the world through a large network of subsidiaries, offices and agencies. It offers its commercial and retail customers a full range of banking and financial services, including lending, stock-broking, insurance broking, fund management, leasing, factoring, investment banking and the provision of funds for venture capital purposes.

The Issuer was incorporated under Dutch law in the Netherlands on 12 November 1927 for an indefinite duration in the form of a public limited company. It is registered at the Chamber of Commerce in Amsterdam under no. 33031431. The articles of association were last amended by notarial deed executed on 6 February 2009.

ING Bank N.V. and its consolidated subsidiaries are involved in lawsuits and arbitration cases in The Netherlands and in a number of other countries relating to claims by or against these companies arising in the course of ordinary activities, and also from acquisitions, including their activities as lenders, employers, investors and taxpayers. Several of these cases involve claims for either very large or indefinite amounts. Although it is not feasible to predict or to determine the outcome of all current or impending legal proceedings, ING Bank N.V. is of the opinion that neither it nor any of its consolidated subsidiaries is or has been involved in, or is or has been affected by, any governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which ING Bank N.V. is aware), during a period covering at least the previous 12 months which may have, or have had in the recent past, significant effects, in the context of the issue of the Notes, on the financial position or profitability of ING Bank N.V. or its consolidated subsidiaries.

DESCRIPTION OF THE NOTES

Capitalised terms used in this section but not defined shall be deemed to be defined as such for the purposes of the Conditions set forth in the “Terms and Conditions of the Notes” section of the Securities Note.

General

The Notes are denominated in euro and are expected to be issued by the Issuer on 30 April 2009 (the “**Issue Date**”). Unless redeemed early, the Notes are due to mature on 30 April 2013 (the “**Maturity Date**”). The total amount of the series will be EUR 8,000,000 and each Note has a nominal amount of EUR 1,000 per Note (the “**Specified Denomination**”). The issue price of the Notes is 101 per cent. The Notes are senior notes in bearer form. The Notes will be cleared through Euroclear and Clearstream, Luxembourg.

Interest

The Notes do not bear interest.

Return at Maturity

Subject to Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note and unless previously redeemed or purchased and cancelled as specified below, each Note will be redeemed on the Maturity Date by the Issuer:

- (i) If $Index_{End}$ is equal to or lower than the Barrier Level, by payment of the Final Redemption Amount, which shall be an amount per Note (in the Specified Currency) to be calculated in accordance with the following formula:
$$\text{Specified Denomination} * (1 + \text{Index Performance}); \text{ or}$$
- (ii) If (a) $Index_{End}$ is higher than the Barrier Level and (b) $Index_{End}$ is lower than $Index_{Start}$, by payment of the Final Redemption Amount, which shall be an amount per Note (in the Specified Currency) equal to the Specified Denomination; or
- (iii) If $Index_{End}$ is equal to or higher than $Index_{Start}$, by payment of the Final Redemption Amount, which shall be an amount per Note (in the Specified Currency) to be calculated in accordance with the following formula:
$$\text{Specified Denomination} * (1 + \text{MAX}[0; 2 * \text{MIN}(\text{Index Performance}; 0.5)])$$

Where:

“**Barrier Level**” means $60\% * Index_{Start}$.

“**Index Performance**” means $\frac{Index_{End}}{Index_{Start}} - 1$.

“**Index_{End}**” means the Index Level on the Expiration Date.

“**Index_{Start}**” means the Index Level on the Strike Date.

“**Expiration Date**” means 23 April 2013, or if such date is not a Scheduled Trading Day, the next following Scheduled Trading Day, in each case subject to Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note.

“**Strike Date**” means 30 April 2009, or if such date is not a Scheduled Trading Day, the next following Scheduled Trading Day, in each case subject to Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note.

“**Index**” Standard and Poor’s GSCI Crude Oil Index (Excess Return) (Bloomberg code: SPGSCLP <INDEX>), or any Successor Index.

“**Index Level**” means on any relevant Scheduled Trading Day, the official closing level of the Index on such Scheduled Trading Day, as calculated and published by the Index Sponsor.

Redemption before the Maturity Date

The Notes may be redeemed before the Maturity Date in the following circumstances:

- (i) an event of default by the Issuer;
- (ii) the imposition of withholding tax on payments in respect of the Notes (at the discretion of the Issuer);
- (iii) if 90 per cent. or more in nominal amount of the Notes issued have already been redeemed (at the discretion of the Issuer).

If the Notes are to be redeemed in the circumstances described in (i), (ii), (iii) above, the Issuer shall redeem each Note at an amount (in euro) equal to the fair market value of a Note determined by the Calculation Agent in its sole and absolute discretion.

Other terms

The Notes include other terms relevant to investors, including the following:

- certain dates for payment of principal on the Notes and determination of the Index Levels to which payments on the Notes are linked will be delayed if, among other things a Disrupted Day (as defined in the “Terms and Conditions of the Notes” section of the Securities Note) occurs.
- the Issuer may amend the terms of the Notes (including amounts payable under them) if an Index Modification, Change of Exchange, Index Cancellation or Index Disruption occurs (all as defined in the “Terms and Conditions of the Notes” section of the Securities Note) or any other event or events occur which the Calculation Agent determines necessitate(s) an adjustment or adjustments to the Final Redemption Amount and/or any other relevant Term of the Notes. Any other events which the Calculation Agent may determine necessitate an adjustment or adjustments may include, but are not limited to, a Price Correction, an event that affects the Specified Currency and a Change in Law (as defined in the “Terms and Conditions of the Notes” section of the Securities Note).

Costs

The costs associated with the issue of the Notes (for marketing, legal work, administration, and distribution of the Notes) are reflected in the pricing of the Notes and will not be separately charged to investors.

No gross-up

All payments made by the Issuer in respect of the Notes shall be made subject to any tax, duty, withholding or other payment which may be required to be made, paid, withheld or deducted. Noteholders will not be entitled to receive grossed-up amounts to compensate for any such tax, duty, withholding or other payment.
