Supplement to the Registration Document dated 13 February 2012

This Supplement (the "Supplement") is prepared as a supplement to, and must be read in conjunction with, the Registration Document dated 13 February 2012 as supplemented by the supplements dated 6 March 2012, 11 May 2012 and 16 May 2012 issued by ING Americas Issuance B.V. (the "Registration Document"). This Supplement, together with the Registration Document, constitutes a registration document for the purposes of Article 5 of Directive 2003/71/EC of the European Parliament and of the Council (as amended from time to time, the "Prospectus Directive"). Terms used but not defined in this Supplement have the meanings ascribed to them in the Registration Document. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Registration Document by this Supplement and (b) any other statement in or incorporated by reference in the Registration Document, the statements in (a) above will prevail. ING Bank N.V. (the "Guarantor") and ING Americas Issuance B.V. (the "Issuer") accept responsibility for the information contained in this Supplement. To the best of the knowledge of the Guarantor and the Issuer (which have each taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

INTRODUCTION

No person has been authorised to give any information or to make any representation not contained in or not consistent with the Registration Document and this Supplement and, if given or made, such information or representation must not be relied upon as having been authorised by the Guarantor or the Issuer.

Neither the delivery of this Supplement nor the Registration Document shall in any circumstances imply that the information contained in such Registration Document and herein concerning the Issuer is correct at any time subsequent to 16 May 2012 (in the case of the Registration Document) or the date hereof (in the case of this Supplement).

So long as the Registration Document and this Supplement are valid as described in Article 9 of the Prospectus Directive, copies of this Supplement and the Registration Document, together with the other documents listed in the “General Information – Documents Available for Inspection or Collection” section of the Registration Document and the information incorporated by reference in the Registration Document by this Supplement, will be available free of charge from the Guarantor and the specified office of the Paying Agents. The distribution of the Registration Document and this Supplement may be restricted by law in certain jurisdictions. Persons into whose possession the Registration Document and/or this Supplement come must inform themselves about, and observe, any such restrictions.

RECENT DEVELOPMENTS AND INFORMATION INCORPORATED BY REFERENCE

On 18 June 2012, the Guarantor published a supplement to its registration document, a copy of which has been approved by and filed with the AFM and, by virtue of this Supplement, is incorporated into and forms part of the Registration Document.

In addition, on 15 June 2012, Moody's announced that it has downgraded ING Bank N.V. and certain of its branches and subsidiaries, including the Issuer, along with other selected French and Benelux banks, as part of its wider review of European banks announced on 15 February 2012. As a result, the Guarantor now has a senior debt rating from Moody's of A2 (outlook negative) and the Issuer has a senior debt rating from Moody's of (P) A2 (outlook negative).

MODIFICATIONS TO THE REGISTRATION DOCUMENT

1. The term “ING Bank N.V. Registration Document” as used in the first paragraph of item (c) in the section entitled “Documents Incorporated by Reference” beginning on page 4 of the Registration Document shall be deleted and restated as follows:

“(c) the registration document of the Guarantor dated 11 May 2012 prepared in accordance with Article 5 of the Prospectus Directive and approved by the AFM (together with the supplements thereto dated 16 May 2012 and 18 June 2012, the “ING Bank N.V. Registration Document”) including, for the purpose of clarity, the following items incorporated by reference therein:”.

2. The following item (v) shall be inserted at the end of paragraph (c) of the section entitled “Documents Incorporated by Reference” beginning on page 4 of the Registration Document:

“(v) the press release published by the Guarantor on 12 June 2012 entitled “ING Bank reaches agreement with US Authorities.”.

3. *The following section shall be inserted immediately following the section entitled “General Information – Guarantee” on page 7 of the Registration Document:*

“Ratings

The Issuer has a senior debt rating from Moody’s France SAS (“Moody’s”) of (P) A2 (outlook negative).

A credit rating is not a recommendation to buy, sell or hold securities. There is no assurance that a rating will remain for any given period of time or that a rating will not be suspended, lowered or withdrawn by the relevant rating agency if, in its judgement, circumstances in the future so warrant. Over the course of the past year, the Issuer has from time to time been subject to its ratings being lowered.”.
