Fourth Supplement to the Base Prospectus dated 15 February 2012

This Supplement (the "Supplement") is supplemental to, forms part of and must be read and construed in conjunction with, the base prospectus dated 15 February 2012 (the "Base Prospectus") as supplemented by the first supplement dated 6 March 2012, the second supplement dated 11 May 2012 and the third supplement dated 16 May 2012 (the Base Prospectus as so supplemented the "Prospectus"). The Base Prospectus has been issued by ING Bank N.V. (the "Issuer") in respect of a €30,000,000,000 Covered Bonds Programme (the "Programme"). This Supplement, together with the Prospectus, constitutes a base prospectus for the purposes of Article 5.4 of Directive 2003/71/EC of the European Parliament and of the Council, as amended from time to time (the "Prospectus Directive"). Terms given a defined meaning in the Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Prospectus by this Supplement and (b) any other statement in or incorporated by reference into the Prospectus, the statements referred to in (a) above will prevail. The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

On page 10 under the section entitled "A.1 COVERED BONDS" in the first paragraph of the sub-paragraph entitled "Credit ratings", the words "The Issuer has a senior debt rating from Standard & Poor's of A+, from Moody's of Aa3 and from Fitch of A+" are replaced with "The Issuer has a senior debt rating from Standard & Poor's of A+ (outlook stable), from Moody's of A2 (outlook negative) and from Fitch of A+ (outlook stable)".

3) Chapter B. KEY FEATURES OF THE PROGRAMME

On page 56 under the section entitled "B.1 Overview" in the sub-paragraph entitled "Ratings", the words "As at the February 2012 Update, the Issuer has a senior debt rating from Standard & Poor's of A+, from Moody's of Aa3 and from Fitch of A+" are replaced with "As at 15 June 2012, the Issuer has a senior debt rating from Standard & Poor's of A+ (outlook stable), from Moody's of A2 (outlook negative) and from Fitch of A+ (outlook stable)".

4) Chapter D. DOCUMENTS INCORPORATED BY REFERENCE; DEFINITIONS & INTERPRETATION

(i) On page 64 under the section entitled "D.1 DOCUMENTS INCORPORATED BY REFERENCE" in the sub-paragraph (A) of the first paragraph, the words "the registration document of the Issuer dated 11 May 2012 prepared in accordance with Article 5 of the Prospectus Directive and approved by the AFM (together with the supplement thereto dated 16 May 2012)" are replaced with "the registration document of the Issuer dated 11 May 2012 prepared in accordance with Article 5 of the Prospectus Directive and approved by the AFM (together with the supplements thereto dated 16 May 2012 and 18 June 2012)".

(ii) On page 64 under the section entitled "D.1 DOCUMENTS INCORPORATED BY REFERENCE", in sub-paragraph (A), the word "and" is deleted at the end of sub-paragraphs (ii) and (iii) and the following item is inserted at the end of sub-paragraph (A):

"(v) the press release published by the Issuer on 12 June 2012 entitled "ING Bank reaches agreement with US Authorities"; and".

5) Section 8. GENERAL INFORMATION

On page 267 under the section entitled "8. GENERAL INFORMATION" under the heading "Documents Available", sub-paragraph (ii) shall be deleted and restated as follows:

"(ii) the Registration Document of the Issuer dated 11 May 2012 and the supplements thereto dated 16 May 2012 and 18 June 2012;".
