### **Certificates and Warrants Programme**

This Base Prospectus supplement (the '**Base Prospectus Supplement**') constitutes a base prospectus supplement for the purposes of Directive 2003/71/EC (the '**Prospectus Directive**') and the Dutch Financial Supervision Act (*Wet op het financieel toezicht*) and regulations thereunder (together, '**Dutch securities laws**') and is prepared in connection with the Certificates and Warrants Programme (the '**Programme**') under which Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (Rabobank Structured Products) ('**Rabobank Structured Products**', the '**Bank**' or the '**Issuer**'), may, subject to compliance with all relevant laws, regulations and directives, from time to time issue leveraged certificates, warrants and certificates (the '**Securities**').

This Base Prospectus Supplement is supplemental to, and should be read in conjunction with, the base prospectus dated 27 October 2011, the base prospectus supplement dated 30 November 2011, the base prospectus supplement 8 December 2011, the base prospectus supplement dated 15 December 2011, the base prospectus supplement dated 16 February 2012 and the base prospectus supplement dated 15 June 2012 (together, the '**Base Prospectus**'). Capitalised terms used but not otherwise defined in this Base Prospectus Supplement shall have the meanings ascribed thereto in the Base Prospectus. To the extent that there is any inconsistency between (a) any statement in this Base Prospectus Supplement or any statement incorporated by reference into the Base Prospectus by this Base Prospectus Supplement and (b) any other statement in or incorporated by reference into the Base Prospectus, the statements in (a) will prevail.

Save as disclosed in this Base Prospectus Supplement, no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus has arisen or been noted, as the case may be, since the publication of the base prospectus supplement dated 15 June 2012.

This Base Prospectus Supplement has been submitted to and approved by the Netherlands Authority for the Financial Markets (*Autoriteit Financiële Markten*) in its capacity as competent authority under the Prospectus Directive and Dutch securities laws.

In accordance with Article 5:23(6) of the Dutch Financial Supervision Act (*Wet op het financieel toezicht*), investors who have agreed to purchase or subscribe for Notes issued under the Programme before the Base Prospectus Supplement is published have the right, exercisable before the end of the period of two business days beginning with the business day after the date on which this Base Prospectus Supplement was published, to withdraw their acceptances.

Therefore, the Base Prospectus shall be amended as follows.

On page 27 of the Base Prospectus the wording under (E) and (F) shall be deleted and replaced with the following:

- “(E) the unaudited interim report of Rabobank Group for the six-month period ended 30 June 2011 and the review report on the condensed consolidated interim financial information in respect thereof;
- (F) the most recent articles of association of the Issuer; and
- (G) the interim report of Rabobank Group for the six months ended 30 June 2012 containing the condensed consolidated interim financial information of Rabobank Group for six months ended 30 June 2012.”
