- 2. This Supplement constitutes a supplemental prospectus to the Registration Document for the purposes of Article 5:23 of the Financial Supervision Act (*Wet op het financial toezicht*).
- 3. This Supplement is supplemental to, and should be read in conjunction with, the Registration Document and any other supplements thereto issued by Holding and/or RBS N.V.
- 4. Each of Holding and RBS N.V. accepts responsibility for the information contained in this Supplement. To the best of the knowledge of Holding and RBS N.V. (having taken all reasonable care to ensure that such is the case), the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.
- 5. On 9 June 2010, Holding published a press release reporting its first quarter financial results for the three months ended 31 March 2010 (the **Press Release**).
- 6. A copy of the Press Release has been filed with the AFM and, by virtue of this Supplement, the Press Release is incorporated into, and forms part of, the Registration Document.
