This summary note (the “**Summary Note**”) has been prepared in connection with the issue by ING Bank N.V. (the “**Issuer**”) of a minimum of 2,000 units of Worst of Memory Phoenix Autocallable Note due February 2017 (the “**Notes**”) under its €50,000,000,000 Global Issuance Programme (the “**Programme**”).

This Summary Note constitutes a summary note and, together with the Registration Document and the Securities Note (each as defined below), a prospectus (the “**Prospectus**”) for the purposes of Article 5 of Directive 2003/71/EC (the “**Prospectus Directive**”) for the purpose of giving information with regard to the Issuer and the Notes which, according to the particular nature of the Issuer and the Notes, is necessary to enable investors to make an informed assessment of the assets and liabilities, financial position, profit and losses and prospects of the Issuer and of the rights attached to the Notes.

The Issuer accepts responsibility for the information contained in this Summary Note. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case), the information contained in this Summary Note, when read together with the Registration Document and the Securities Note, is in accordance with the facts and does not omit anything likely to affect such information.

On 31 March 2011, the Issuer published a base prospectus (the “**Original Base Prospectus**”) in respect of the Programme. On 11 May 2011, 21 June 2011, 11 August 2011 and 7 November 2011 respectively, the Issuer published a supplement to the Original Base Prospectus (each a “**BP Supplement**”, together the “**BP Supplements**”) and together with the Original Base Prospectus, the “**Base Prospectus**”). On 11 May 2011 the Issuer published a registration document (the “**Original Registration Document**”). On 21 June 2011, 11 August 2011 and 7 November 2011 respectively, the Issuer published a supplement to the Original Registration Document (each a “**RD Supplement**”, together the “**RD Supplements**”) and together with the Original Registration Document, the “**Registration Document**”). On the date hereof, the Issuer published a securities note in respect of the issue of the Notes (the “**Securities Note**”). DESCRIPTION OF THE ISSUER

The Issuer is a subsidiary company of ING Groep N.V., also called ING Group. ING Group is the holding company of a broad spectrum of companies (together called “ING”), offering banking, investments, life insurance and retirement services to about 85 million private, corporate and institutional clients in Europe, the United States, Canada, Latin America, Asia and Australia. Originating from The Netherlands, ING has a workforce of about 107,000 people worldwide. ING Group holds all shares of the Issuer, which is a non-listed 100% subsidiary of ING Group. On 26 October 2009, ING announced a new strategic direction. It will separate its banking and insurance operations and develop towards a mid-sized international Bank, anchored in the Netherlands and Belgium, and predominantly focused on the European retail market with selected growth options elsewhere. On the same date, ING announced that all Insurance operations (including Investment Management) would be divested over the following four years.

In 2010, the Issuer introduced a new reporting structure reflecting two main business lines: Retail Banking and Commercial Banking. Under this structure, ING Direct has been included within Retail Banking. This reporting structure has been applied in respect of the Issuer’s annual report for the year ended 31 December 2010 and the banking business disclosure included in the ING Group quarterly reports as from the first quarter of 2010.

The Issuer is a large international player with an extensive global network in over 40 countries. It has strong established positions in The Netherlands, Belgium and Luxembourg and key positions in Poland, Romania and Turkey, the largest Central and Eastern Europe markets. The Issuer holds strong positions in Germany, France, Italy, Spain, the United Kingdom and the United States. The Issuer also has profitable businesses in Canada and Asia/Pacific. It has an extensive international network to service and support its corporate clients. From 1 January 2011, the Issuer began operating as a stand-alone company. With more than 72,000 employees, the Issuer is active through the following Business Lines: Retail Banking, including ING Direct and Commercial Banking.

Retail Banking provides retail and private banking services to individuals and small and medium-sized enterprises in The Netherlands, Belgium, Luxembourg, Poland, Romania, Turkey, India, Thailand and China (through a stake in Bank of Beijing) with a multiproduct, multi-channel distribution approach. In mature markets, Retail Banking focuses on wealth accumulation, savings and mortgages, with an emphasis on operational excellence, cost leadership and customer satisfaction. In developing markets, Retail Banking aims to become a prominent local player by offering simple but high quality products. ING Direct offers direct banking services in Canada, Spain, Australia, France, the US, Italy, Germany, the United Kingdom and Austria. ING Direct’s focus is on offering five simple and transparent retail banking products at very low cost: savings, mortgages, payment accounts, investment products and consumer lending.

Commercial Banking offers core banking services such as lending, payments and cash management in more than 40 countries. It provides clients with tailored solutions in areas including corporate finance, structured finance, commercial finance, equity markets, financial markets and leasing. Clients are corporations – ranging from medium-sized and large companies to major multinationals – as well as governments and financial institutions.

The Issuer was incorporated under Dutch law in The Netherlands on 12 November 1927 for an indefinite duration in the form of a public limited company. The Issuer is registered at the Chamber of Commerce of Amsterdam under no. 33031431 and its corporate seat is in Amsterdam, The Netherlands. The articles of association were last amended by notarial deed executed on 30 December 2009.

The Issuer and its consolidated subsidiaries are involved in litigation and arbitration proceedings in The Netherlands and in a number of foreign jurisdictions, including the United States, involving claims by and against them which arise in the ordinary course of their businesses, including in connection with their

activities as insurers, lenders, employers, investors and taxpayers, certain examples of which are described immediately below. In certain of such proceedings, very large or indeterminate amounts are sought, including punitive and other damages. While it is not feasible to predict or to determine the outcome of all pending or threatened legal and regulatory proceedings, the Issuer is of the opinion that neither it nor any of its consolidated subsidiaries is aware of any governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which the Issuer is aware) in the 12 months period preceding the date on which the Prospectus was filed with the AFM and approved by it, which may have, or have in such period had a significant effect on the financial position or profitability of the Issuer and/or its consolidated subsidiaries.

Because of the geographic spread of its business, the Issuer may be subject to tax audits in numerous jurisdictions at any point in time. Although the Issuer believes that it has adequately provided for all its tax positions, the ultimate resolution of these audits may result in liabilities which are different from the amounts recognised.

Purported class litigation has been filed in the United States District Court for the Southern District of New York alleging violations of the federal securities laws with respect to disclosures made in connection with the 2007 and 2008 offerings of ING's Perpetual Hybrid Capital Securities. The Court has determined that the claims relating to the 2007 offerings were without merit and has dismissed them. The challenged disclosures that survived the Court's ruling relate solely to the June 2008 offering, and primarily to ING Group's investments in certain residential mortgage-backed securities.

In January 2010 ING lodged an appeal with the General Court of the European Union against specific elements of the European Commission's decision regarding ING's restructuring plan. In its appeal, ING contests the way the European Commission has calculated the amount of state aid ING received and the disproportionality of the price leadership restrictions specifically and the disproportionality of restructuring requirements in general.

In January 2011 the Association of Stockholders (Vereniging van Effectenbezitters, "VEB") issued a writ alleging that investors were misled by the prospectus that was issued with respect to the September 2007 rights issue of Fortis N.V. (now: Ageas N.V.) against Ageas N.V., the underwriters of such rights issue, including the Issuer, and former directors of Fortis N.V. According to the VEB the prospectus shows substantive incorrect and misleading information. The VEB states that the impact and the risks of the subprime crisis for Fortis and Fortis' liquidity position have been reflected incorrectly in the prospectus. The VEB requests a declaratory decision stating that the summoned parties have acted wrongfully and are therefore responsible for the damages suffered by the investors in Fortis. The amount of damages of EUR 18 billion, has not been substantiated yet. ING will defend itself against this claim; at this time ING is not able to assess the future outcome.

In March 2011, ING Groep N.V. was informed of the decision of the board of Stichting Pensioenfonds ING (the Dutch ING Pension Fund) to institute arbitration against ING's decision not to provide funding for indexing pensions. While it is not feasible to predict the ultimate outcome of these arbitration proceedings, ING Groep N.V. is of the opinion that these will not have a significant effect on the financial position or profitability of ING Groep N.V.

DESCRIPTION OF THE NOTES

Capitalised terms used in this section but not defined shall be deemed to be defined as such for the purposes of the Conditions set forth in the “Terms and Conditions of the Notes” section of the Securities Note.

GENERAL

The Notes are denominated in SEK and are expected to be issued by the Issuer on 15 February 2012 (the “**Issue Date**” and the “**Interest Commencement Date**”). Unless redeemed early, the Notes are due to mature on 22 February 2017 (the “**Maturity Date**”). The total amount intend to be issued will be a minimum of 2,000 units and each Note comprises 1 unit (the “**Specified Denomination**”). The issue price of the Notes is SEK 10,000 per unit. The Notes are senior notes in uncertificated and dematerialised book-entry form. The Notes will be cleared through Euroclear Sweden AB and a request will be made to have the Notes admitted to trading on the regulated market of the Luxembourg Stock Exchange.

INTEREST

(i) *Interest Payment Dates*

Each Note bears a variable-linked interest from (but excluding) the Interest Commencement Date and such interest, if any, will be payable in arrear on the Specified Interest Payment Date(s), as defined below (each an “**Interest Payment Date**”).

(ii) *Determination of the Variable-linked Interest*

In respect of each Interest Period, as specified in Condition 3(i) of the “Terms and Conditions of the Notes” section of the Securities Note, the Variable-linked Interest payable, if any, on the Interest Payment Date immediately following the relevant Observation Date_t shall be determined in accordance with the following:

- (1) If, on the relevant Observation Date_t, the Level of each and every Equity in the Basket is equal to or higher than its relevant Barrier Level, an amount per Note calculated in accordance with the following formula:
$$[\text{SEK } 10,000 \times t \times \text{Coupon}] - \text{Memory Coupon}; \text{ or}$$
- (2) If, on the relevant Observation Date_t, the Level of at least one of the Equities in the Basket is lower than its relevant Barrier Level, an amount per Note equal to SEK 0.00 (ZERO), in which case no Variable-linked Interest shall be paid on the Notes.

Where:

“**Coupon**” means 11.50% (indicative, the final Coupon shall be determined by the Issuer on or about 15 February 2012 and shall be announced on www.ingmarkets.com. The final Coupon shall not be less than 8%);

“**Specified Interest Payment Date(s)**” means 22 February 2013, 24 February 2014, 23 February 2015, 22 February 2016 and the Maturity Date, subject to adjustment in accordance with Condition 3(i) and Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note;

“**Level**” means (i) in respect of Equity₁ and Equity₂, the relevant Price and (ii) in respect of Equity₃ and Equity₄, the relevant Index Level;

“**Memory Coupon**” means the sum of all Variable-linked Interest payable on the Interest Payment Dates preceding Observation Date_t, except for Observation Date₁ in which case Memory Coupon means SEK 0.00 (ZERO);

“**Observation Date(s)**” means 15 February 2013, 17 February 2014, 16 February 2015, 15 February 2016 and Expiration Date, or if any such date is not a Scheduled trading Day, the next Scheduled Trading Day, in each case subject to Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note. Each Observation Date may be referred to as Observation Date_t, where “t” means the number 1 to 5. (e.g. if t=1, Observation Date₁ means 15 February 2013); and

“**t**” means the number 1 or 5 corresponding to the relevant Observation Date_t.

RETURN AT MATURITY

Unless previously redeemed or purchased and cancelled each Note will be redeemed on the Maturity Date by the Issuer at the Final Redemption Amount which shall be an amount per Note determined in accordance with the following:

- (i) If the Final Level of each and every Equity in the Basket is equal to or higher than its relevant Barrier Level, by payment of the Final Redemption Amount, which shall be an amount per Note equal to SEK 10,000; or
- (ii) If the Final Level of at least one of the Equities in the Basket is lower than its relevant Barrier Level, by payment of the Final Redemption Amount, which shall be an amount per Note calculated in accordance with the following formula:

Where:

“Basket” means a basket composed of Equity₁, Equity₂, Equity₃ and Equity₄ (for the avoidance of doubt, Equity₁, Equity₂, Equity₃ and Equity₄ may be referred to as Equity in the context of the Basket);

“Barrier Level” means (i) in respect of Equity₁ and Equity₂, the Barrier Level Percentage multiplied by the relevant Strike Price and (ii) in respect of Equity₃ and Equity₄, the Barrier Level Percentage multiplied by the relevant Initial Index Level;

“Barrier Level Percentage” means 60%;

“Index” means (i) Hang Seng China Enterprise Index (Bloomberg code: HSCEI <Index>) (**“Equity₃”**) and (ii) Russian Depositary Index (Bloomberg code: RDXUSD <Index>) (**“Equity₄”**). For the avoidance of doubt, Equity₃ and Equity₄, may (a) together be referred to as Indices and (b) separately as Index;

“Final Level” means (i) in respect of Equity₁ and Equity₂, the relevant Final Share Price and (ii) in respect of Equity₃ and Equity₄, the relevant Final Index Level;

“Initial Level” means (i) in respect of Equity₁ and Equity₂, the relevant Strike Price and (ii) in respect of Equity₃ and Equity₄, the relevant Initial Index Level;

“Equity_{wo}” means the Equity with the worst performance compared to the other Equities in the Basket, where the performance of each of the Equities in the Basket will be calculated in accordance with the following formula:

$$(\text{Final Level} / \text{Initial Level}) \times 100\%$$

For the avoidance of doubt, Equity_{wo} will be the Equity for which the outcome of the above mentioned formula has the lowest value;

“Shares” means (i) the shares issued by Share Issuer₁ (ISIN code: US4642864007; Bloomberg code: EWZ UP <Equity>) (**“Equity₁”**) and (ii) the shares issued by Share Issuer₂ (ISIN code: US97717W4226; Bloomberg code: EPI UP <Equity>) (**“Equity₂”**); and

“Share Issuer” means (i) iShares MSCI Brazil Index Fund in case of Equity₁ (**“Share Issuer₁”**) and (ii) Wisdomtree India Earnings Fund in case of Equity₂ (**“Share Issuer₂”**).

AUTOMATIC EARLY REDEMPTION

Unless previously redeemed or purchased and cancelled, if on any Automatic Early Redemption Valuation Date the Automatic Early Redemption Event occurs, then the Notes will be automatically redeemed in whole, but not in part, on the Automatic Early Redemption Date immediately following such Automatic Early Redemption Valuation Date, and in any such case the Final Redemption Amount payable by the Issuer on such date upon redemption of each Note shall be an amount equal to the Automatic Early Redemption Amount.

Where:

“Automatic Early Redemption Valuation Date” means 15 February 2013, 17 February 2014, 16 February 2015 and 15 February 2016 or, if any such Automatic Early Redemption Valuation Date is not a Scheduled Trading Day, the next following Scheduled Trading Day, in each case subject to adjustment in accordance with Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note;

“Automatic Early Redemption Event” means the Level of each and every Equity in the Basket is equal to or higher than its relevant Trigger Level;

“Automatic Early Redemption Date” means 22 February 2013, 24 February 2014, 23 February 2015 and 22 February 2016, subject in each case to adjustment in accordance with Condition 18(a) of the “Terms and Conditions of the Notes” section of the Securities Note;

“Automatic Early Redemption Amount” means an amount per Note equal to SEK 10,000

“Trigger Level” means (i) in respect of Equity₁ and Equity₂, the Trigger Level Percentage multiplied by the relevant Strike Price and (ii) in respect of Equity₃ and Equity₄, the Trigger Level Percentage multiplied by the relevant Initial Index Level; and

“Trigger Level Percentage” means 80%.

REDEMPTION PRIOR TO MATURITY (OTHER THAN AUTOMATIC EARLY REDEMPTION)

The Notes may be redeemed before the Maturity Date in the following circumstances (other than an automatic early redemption as set out above):

- (i) an event of default by the Issuer;
- (ii) if 90 per cent. or more of the Notes issued have already been redeemed (at the discretion of the Issuer); and
- (iii) If the Calculation Agent determines that that an early redemption event, as specified in Condition 5(d) of the “Terms and Conditions of the Notes” section of the Securities Note, has occurred; and
- (iv) If the Calculation Agent determines that an Additional Disruption Event, an Index Modification, an Index Cancellation, an Index Disruption, any other Relevant Event, a Merger Event, a Tender Offer, a Nationalisation, an Insolvency and/or a De-listing, as described in Condition 18 and/or 20 of the “Terms and Conditions of the Notes” section of the Securities Note, has occurred.

If the Notes are to be redeemed in the circumstances described in (i), (ii), (iii) and (iv) above, the Issuer shall redeem each Note at an amount (in SEK) equal to the fair market value of a Note determined by the Calculation Agent in its sole and absolute discretion.

OTHER TERMS

The Notes include other terms relevant to investors, including (but not limited to) the following: The Issuer may amend the terms of the Notes (including amounts payable under them) if, (i) in respect of Equity₁ and Equity₂, a Potential Adjustment Event and/or that there has been an adjustment to the settlement terms of listed contracts on the Shares traded on a Related Exchange, and/or (ii) in respect of Equity₃ and Equity₄, an Index Modification, an Index Cancellation, and/or an Index Disruption, has occurred (all as defined in the Terms and Conditions of the Notes section of the Securities Note) and/or any other event or events (as described in Condition 18 and/or 20 of the “Terms and Conditions of the Notes” section of the Securities Note) occur which the Calculation Agent determines necessitate(s) an adjustment or adjustments to the Final Redemption Amount, the Automatic Early Redemption Amount, the Early Redemption Amount, any amount of interest payable (if any) and/or any other relevant term of the Notes.

COSTS

The costs associated with the issue of the Notes (for marketing, legal work, administration, and distribution of the Notes) are reflected in the pricing of the Notes and will not be separately charged to investors. A commission fee of 2.00% may be separately charged to investors by the distributor.

RISK FACTORS

Investing in the Notes involves risks. The Notes are not principal protected and the market value of the Notes may fluctuate during their term. Prospective investors risk losing their entire investment or part of it. See Parts 1 and 2 of the “Risk factors” section of Chapter 1 of the Base Prospectus, and the risk factors below for information on the risk factors to be taken into account when considering an investment in the Notes. Potential investors are strongly recommended to consult with their financial advisers before making any investment decision.

The Notes may not be a suitable investment for all investors

No gross-up

Noteholders will not be entitled to receive grossed-up amounts to compensate for any such tax, duty, withholding or other payment.
