This Supplement dated 28 February 2008 (the **Supplement**) constitutes the third supplement to the base prospectus dated 29 August 2007 in relation to the EUR 25,000,000,000 Covered Bond Programme (the **Base Prospectus**) established by ABN AMRO Bank N.V. (the **Issuer**) and approved by the Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the **AFM**) on 29 August 2007, as supplemented on 11 October 2007 and 1 November 2007.
2. The Base Prospectus was approved as a base prospectus pursuant to the Directive 2003/71/EC by the AFM. This Supplement constitutes a supplemental prospectus to the Base Prospectus for the purposes of Article 5:23 of the Financial Supervision Act (*Wet op het financieel toezicht*).
3. This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus and any other supplements thereto issued by the Issuer.
4. The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (having taken all reasonable care to ensure that such is the case), the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.
5. On 28 February 2008, ABN AMRO Holding N.V. announced the publication of the consolidated annual results of the ABN AMRO Group for the 12 months ended 31 December 2007.
6. A copy of the abovementioned announcement has been filed with the AFM and, by virtue of this Supplement, that announcement is incorporated in, and forms part of, the Base Prospectus.
