REINET INVESTMENTS S.C.A. SHARE BUYBACK PROGRAMME – UPDATE 23 SEPTEMBER 2019

Reinet Investments S.C.A. has repurchased 289 931 ordinary shares in the period 16 to 20 September 2019. The shares were repurchased on the Johannesburg Stock Exchange at an average price of ZAR 269.59 per share (highest price: ZAR 278.11; lowest price: ZAR 259.61) for a total consideration of some ZAR 78.16 million (€ 4.8 million), plus transaction costs. These repurchases were made as part of the share buyback programme announced on 6 September 2019.

The total number of shares repurchased under this programme to date is 421 811 ordinary shares for a total consideration of some ZAR 112.32 million (€ 6.9 million), plus transaction costs.
