AkzoNobel (AKZA; AKZOY) has repurchased 491,075 of its own ordinary shares in the period from September 23, 2019 up to and including September 27, 2019, at an average price of €80.21 per share. The consideration of the repurchase was €39.39 million.

This is part of a repurchase program announced on February 13, 2019. The total number of shares repurchased under this program to date is 27,811,760 ordinary shares for a total consideration of €2,198.50 million.

AkzoNobel intends to repurchase common shares up to a value of €2.5 billion as part of a total €6.5 billion being distributed to shareholders following the sale of the Specialty Chemicals business. The share buyback is due to be completed by the end of 2019.
