

Ahold Delhaize share buyback update

Zaandam, the Netherlands, September 10, 2019 – Ahold Delhaize has repurchased 281,400 of Ahold Delhaize common shares in the period from September 2, 2019 up to and including September 6, 2019. The shares were repurchased at an average price of €21.56 per share for a total consideration of €6.1 million. These repurchases were made as part of the €1 billion share buyback program announced on November 13, 2018.

The total number of shares repurchased under this program to date is 35,112,687 common shares for a total consideration of €756.8 million.
