### DSM - Repurchase of shares (9 - 13 September 2019)

Royal DSM, a global science-based company in Nutrition, Health and Sustainable Living, has repurchased 245,676 of its own shares in the period from 9 September 2019 up to and including 13 September 2019 at an average price of €113.21. This is in accordance with the repurchase announced on 14 March 2019, covering the intended reduction of issued capital as well as commitments under share-based compensation plans and for stock dividends. The consideration of this repurchase was €27.8 million.

The total number of shares repurchased under this program to date is 3,970,655 shares for a total consideration of €417.7 million.
