InPost S.A. announces pricing of Euro-Denominated Senior Notes Offering

Luxembourg, Luxembourg – 24 June 2021. InPost S.A. (“InPost” or the “Issuer”) today announces the successful pricing of an offering (the “Offering”) of €490 million in aggregate principal amount of euro-denominated 2.250% senior notes due 2027 (the “Notes”) at par. The Offering was upsized from the previously announced €390 million. The Offering is expected to close on 29 June 2021, subject to customary closing conditions.

InPost intends to utilize the proceeds from the Offering (together with drawings under its existing revolving credit facility) (i) to consummate the previously announced acquisition (the “Acquisition”) of Mondial Relay SAS, (ii) to pay fees and expenses in connection with the Acquisition and the related financing transactions and (iii) for general corporate purposes.

This press release contains inside information relating to InPost S.A. within the meaning of Regulation (EU) 596/2014 and Commission Implementing Regulation (EU) 2016/1055.
