

Ahold Delhaize share buyback update

Zaandam, the Netherlands, April 24, 2018 - Ahold Delhaize has repurchased 2,398,940 of Ahold Delhaize common shares in the period from April 16, 2018 up to and including April 20, 2018. The shares were repurchased at an average price of €19.16 per share for a total consideration of €46 million. These repurchases were made as part of the €2 billion share buyback program announced on November 8, 2017.

The total number of shares repurchased under this program to date is 30,822,518 common shares for a total consideration of €562.5 million.
