Van Lanschot Kempen: update on share buy-back programme 30 April 2019 – 6 May 2019

Amsterdam/'s-Hertogenbosch, the Netherlands, 7 May 2019

In the period from 30 April 2019 until 6 May 2019 Van Lanschot Kempen has repurchased 26,223 of its own shares (depositary receipts for Class A ordinary shares). The shares were repurchased at an average price of €23.25 per share for a total amount of €609,603.

These repurchases are part of the share buy-back programme for at most 370,000 of own shares, which was announced on 21 February 2019. The total number of shares repurchased to date is 227,650.
