## Share Buyback Transaction Details April 25 – May 1, 2019

# May 2, 2019 - Wolters Kluwer today reports that it has repurchased 53,456 of its own ordinary shares in the period from April 25, 2019, up to and including May 1, 2019, for €3.3 million and at an average share price of €62.09.

These repurchases are part of the share buyback program announced on February 20, 2019, under which we intend to repurchase shares for up to €250 million during 2019.

The cumulative amounts repurchased to date under this program are as follows:

For the period starting February 22, 2019, up to and including May 6, 2019, we have engaged a third party to execute €40 million of buybacks on our behalf, within the limits of relevant laws and regulations (in particular Regulation (EU) 596/2014) and the company's Articles of Association.

Repurchased shares are added to and held as treasury shares and will be used for capital reduction purposes or to meet obligations arising from share-based incentive plans.
