



Allocation of options

Reference is made to the stock notices of Funcom N.V. published on 12 May 2017 and on 27 June 2017 regarding the Annual General Meeting of Shareholders.

On 7 July 2017 the following Supervisory Directors and Managing Directors were granted rights to acquire the following number of (depository ownership in) shares in the capital of Funcom N.V. as specified below (the "Option Rights"):

Furthermore, following the mandate granted by Funcom N.V.'s General Meeting of Shareholders on 27 June 2017, the Supervisory Board of Funcom N.V. has granted on 7 July 2017 5,544,000 Option Rights to employees of the Company. The Option Rights granted to employees have been allocated to primary insiders as follows:
