DSM finalizes repurchase of shares to cover existing option plans and stock dividends

Royal DSM, a global science-based company active in health, nutrition and materials, has repurchased 261,898 of its own shares in the period from 7 July 2017 up to and including 13 July 2017 at an average price of \notin 63.24. This is in accordance with the repurchase, covering existing option plans and stock dividends, announced on 13 March 2017. The consideration of this repurchase was \notin 16.6 million.

This repurchase concludes the program to repurchase 2,900,000 shares for a total consideration of €187.2 million.
