## DSM - repurchase of shares (5 - 11 May 2017)

Royal DSM, a global science-based company active in health, nutrition and materials, has repurchased 128,958 of its own shares in the period from 5 May 2017 up to and including 11 May 2017 at an average price of €65.76. This is in accordance with the repurchase, covering existing option plans and stock dividends, announced on 13 March 2017. The consideration of this repurchase was €8.5 million.

The total number of shares repurchased under this program to date is 1,472,098 shares for a total consideration of €94.1 million.
