Jan Nijssen to be nominated for appointment as member of the SNS REAAL Supervisory Board

The Supervisory Board of SNS REAAL N.V. announces its intention to submit the nomination of Mr Jan Nijssen (57) for appointment as a member of the Supervisory Board to the General Meeting of Shareholders.

From 1978 until 2005, Mr Nijssen held several positions at Nationale Nederlanden and ING in the Netherlands and abroad. From 1992, he held several senior management positions with pensions, banking and insurance as areas of focus. Mr Nijssen is partner of Montae, a company that advises businesses, pension funds, trade unions and authorities on collective pensions. Currently, he also serves as Chairman of the Board of Expertisecentrum LEEftijd (an independent centre on age and life course issues) and he was a member of the Frijns Committee (Dutch Corporate Governance Code Monitoring Committee). And finally, through Enviu (innovators in sustainability), Mr Nijssen helps business and institute start-ups to improve the financial well-being of communities in India.

Mr Nijssen is nominated because of his extensive experience in the insurance industry and knowledge of financial services.

It is expected that an Extraordinary Meeting of Shareholders will be convened in August for September of this year. This meeting of Shareholders will be asked to decide on Mr Nijssen's appointment as member of the Supervisory Board. It is also intended to appoint Mr Nijssen as a member of the Supervisory Boards of SNS Bank N.V., REAAL N.V. and SRLEV N.V.

The intended appointment of Mr Nijssen has been approved by the supervisory authorities.
