## Ahold Delhaize share buyback update

Zaandam, the Netherlands, July 9, 2019 - Ahold Delhaize has repurchased 821,400 of Ahold Delhaize common shares in the period from July 1, 2019 up to and including July 5, 2019. The shares were repurchased at an average price of €20.16 per share for a total consideration of €16.6 million. These repurchases were made as part of the €1 billion share buyback program announced on November 13, 2018.

The total number of shares repurchased under this program to date is 30,140,128 common shares for a total consideration of €654.8 million.
