## Van Lanschot Kempen: update on share buy-back programme 16 April 2019 – 18 April 2019

Amsterdam/'s-Hertogenbosch, The Netherlands, 23 April 2019

In the period from 16 April 2019 until 18 April 2019 Van Lanschot Kempen has repurchased 17,069 of its own shares (depositary receipts for Class A ordinary shares). The shares were repurchased at an average price of €21.44 per share for a total amount of €365,911.

These repurchases are part of the share buy-back programme for at most 370,000 of own shares, which was announced on 21 February 2019. The total number of shares repurchased to date is 171,287.
