Van Lanschot Kempen: update on share buy-back programme 9 April 2019 – 15 April 2019

In the period from 9 April 2019 until 15 April 2019 Van Lanschot Kempen has repurchased 25,500 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €21.40 per share for a total amount of €545,808.

These repurchases are part of the share buy-back programme for at most 370,000 of own shares, which was announced on 21 February 2019. The total number of shares repurchased to date is 154,218.
