### **Van Lanschot Kempen: update on share buy-back programme 23 April 2019 – 29 April 2019**

*Amsterdam/'s-Hertogenbosch, the Netherlands, 30 April 2019*

In the period from 23 April 2019 until 29 April 2019 Van Lanschot Kempen has repurchased 30,140 of its own shares (depository receipts for Class A ordinary shares). The shares were repurchased at an average price of €23.13 per share for a total amount of €697,177.

These repurchases are part of the share buy-back programme for at most 370,000 of own shares, which was announced on 21 February 2019. The total number of shares repurchased to date is 201,427.
