Van Lanschot Kempen: update on share buy-back programme 2 April 2019 – 8 April 2019

The Netherlands, Amsterdam/'s-Hertogenbosch, 9 April 2019

In the period from 2 April 2019 until 8 April 2019 Van Lanschot Kempen has repurchased 19,827 of its own shares (depositary receipts for Class A ordinary shares). The shares were repurchased at an average price of €20.92 per share for a total amount of €414,765.

These repurchases are part of the share buy-back programme for at most 370,000 of own shares, which was announced on 21 February 2019. The total number of shares repurchased to date is 128,718.
