Royal DSM, a global science-based company active in health, nutrition and materials, has repurchased 235,605 of its own shares in the period from 24 March 2017 up to and including 30 March 2017 at an average price of  $\leq 62.81$ . This is in accordance with the repurchase, covering existing option plans and stock dividends, announced on 13 March 2017. The consideration of this repurchase was  $\leq 14.8$  million.

The total number of shares repurchased under this program to date is 766,193 shares for a total consideration of €47.9 million.
