Zaandam, the Netherlands, January 30, 2018 - Ahold Delhaize has repurchased 2,506,901 of Ahold Delhaize common shares in the period from January 22, 2018 up to and including January 26, 2018. The shares were repurchased at an average price of €18.43 per share for a total consideration of €46.2 million. These repurchases were made as part of the €2 billion share buyback program announced on November 8, 2017.

The total number of shares repurchased under this program to date is 8,658,173 common shares for a total consideration of €159.3 million.
