

## Ahold Delhaize share buyback update

*Zaandam, the Netherlands, December 18, 2018* - Ahold Delhaize has repurchased 1,715,000 of Ahold Delhaize common shares in the period from December 10, 2018 up to and including December 14, 2018. The shares were repurchased at an average price of €22.40 per share for a total consideration of €38.4 million. These repurchases were made as part of the €2 billion share buyback program announced on November 8, 2017.

The total number of shares repurchased under this program to date is 99,673,708 common shares for a total consideration of €1,976.5 million.
