REINET INVESTMENTS S.C.A. SHARE BUYBACK PROGRAMME – UPDATE 11 DECEMBER 2018

Reinet Investments S.C.A. has repurchased 385 921 ordinary shares in the period 3 December 2018 to 7 December 2018. The shares were repurchased on the Johannesburg Stock Exchange at an average price of ZAR 206.90 per share (highest price: ZAR 215.92; lowest price: ZAR 200.95) for a total consideration of some ZAR 79.85 million (€ 5.1 million), plus transaction costs. These repurchases were made as part of the share buyback programme announced on 19 November 2018.

The total number of shares repurchased under this programme to date is 1 283 370 ordinary shares for a total consideration of some ZAR 266.02 million (€ 16.9 million), plus transaction costs.
