The Board of the Company has resolved with immediate effect to cancel 18,328 of its EUR issued shares, thereby reducing the number of outstanding number of issued EUR shares of the Company to 79,430,940. (the "Transaction")

Following the Transaction, there are now in issue (to the exclusion of those held in treasury) 72,253,100 Euro Shares, 23,926,972 US\$ Shares and 30,768,811 Sterling Shares. The total number of shares held in treasury are 7,177,840 Euro Shares, 2,194,401 US\$ Shares and 2,208,325 Sterling Shares.
