On 26 March 2008, the Company purchased into treasury 100,000 Sterling shares at a range of prices from GBP 9.65 to GBP 9.8 (the "Transaction")

On 26 March 2008, the Company purchased into treasury 130,000 EUR shares at a range of prices from EUR 9.4 to EUR 9.47 (the "Transaction")

The Board of the Company has resolved with immediate effect to cancel 130,000 of its EUR issued shares, thereby reducing the number of outstanding issued EUR shares of the Company to 76,787,498 (the "Transaction")

Following the Transaction, there are now in issue (to the exclusion of those held in treasury) 69,609,658 Euro Shares, 24,808,686 US\$ Shares and 31,062,807 Sterling Shares. The total number of shares held in treasury are 7,177,840 Euro Shares, 2,194,401 US\$ Shares and 2,568,325 Sterling Shares.
