



## Ahold Delhaize share buyback update

*Zaandam, the Netherlands, May 19, 2020* – Ahold Delhaize has repurchased 955,200 of Ahold Delhaize common shares in the period from May 11, 2020 up to and including May 15, 2020. The shares were repurchased at an average price of €22.96 per share for a total consideration of €21.9 million. These repurchases were made as part of the €1 billion share buyback program announced on December 4, 2019.

The total number of shares repurchased under this program to date is 20,652,653 common shares for a total consideration of €444.8 million.
