

Ahold Delhaize share buyback update

Zaandam, the Netherlands, August 14, 2018 - Ahold Delhaize has repurchased 3,706,890 of Ahold Delhaize common shares in the period from August 6, 2018 up to and including August 10, 2018. The shares were repurchased at an average price of €20.93 per share for a total consideration of €77.6 million. These repurchases were made as part of the €2 billion share buyback program announced on November 8, 2017.

The total number of shares repurchased under this program to date is 66,323,542 common shares for a total consideration of €1,286 million.
