## Ahold Delhaize share buyback update

The shares were repurchased at an average price of €18.32 per share for a total consideration of €18.1 million. These repurchases were made as part of the €2 billion share buyback program announced on November 8, 2017.

The total number of shares repurchased under this program to date is 22,759,369 common shares for a total consideration of €409.8 million.
