In this context, a.s.r. distinguishes four roles, i.e. as an insurer, as an employer, as an investor and as a socially responsible company. In addition, a.s.r. contributes to other SDGs. The SDGs are explained in more detail in the Annual Report.

The SFCR has similarities with the Annual Report, but also provides more insight into solvency, based on the Solvency II guidelines.
