## AIR FRANCE AND KLM INCREASE FUEL SURCHARGES

---

Due to the high level of fuel prices, Air France and KLM are increasing their fuel surcharges by

- 4 euros per segment on long-haul flights
- 1 euro on medium-haul flights and 5 euros on long-haul flights for KLM.

This increase, valid on tickets for trips from France and Netherlands issued as from 22 March 2007, will be withdrawn as soon as the price of the barrel goes below 60 US dollars for 30 consecutive days.
