

## Ahold Delhaize share buyback update

*Zaandam, the Netherlands, September 4, 2018* - Ahold Delhaize has repurchased 3,355,808 of Ahold Delhaize common shares in the period from August 27, 2018 up to and including August 31, 2018. The shares were repurchased at an average price of €20.98 per share for a total consideration of €70.4 million. These repurchases were made as part of the €2 billion share buyback program announced on November 8, 2017.

The total number of shares repurchased under this program to date is 74,586,824 common shares for a total consideration of €1,458.6 million.
