

Ahold Delhaize share buyback update

Zaandam, the Netherlands, June 16, 2020 – Ahold Delhaize has repurchased 474,394 of Ahold Delhaize common shares in the period from June 8, 2020 up to and including June 12, 2020. The shares were repurchased at an average price of €23.51 per share for a total consideration of €11.15 million. These repurchases were made as part of the €1 billion share buyback program announced on December 4, 2019.

The total number of shares repurchased under this program to date is 23,196,050 common shares for a total consideration of €511 million.
