Share Buyback Transaction Details June 8 - 14, 2017

June 15, 2017 – Wolters Kluwer today reports that it has repurchased 116,500 of its own ordinary shares in the period from June 8, 2017 up to and including June 14, 2017 for €4.5 million and at an average share price of €38.54.

These share repurchases are part of the three-year (2016-2018), up to €600 million buyback program announced on February 24, 2016. The cumulative number of shares repurchased under this three-year program is as follows:
