



Ahold share buyback update

Zaandam, the Netherlands, October 6, 2014 - Ahold has repurchased 1,875,308 Ahold common shares in the period from September 29, 2014 up to and including October 3, 2014. The shares were repurchased at an average price of € 12.5374 per share for a total consideration of € 23.51 million. These repurchases were made as part of the € 500 million share buyback program announced on February 28, 2013 as increased by € 1.5 billion to a total amount of € 2 billion announced on June 4, 2013.

The total number of shares repurchased under this program to date is 139,892,375 common shares for a total consideration of € 1,816.79 million.
