Progress of buy-back programme

Delta Lloyd Group has repurchased 225,399 Delta Lloyd ordinary shares in the period from August 13, 2010 up to and including August 19, 2010. The shares were bought at a weighted average price of € 14.32 per share.

In the period from June 11, 2010 up to and including August 19, 2010, the total number of Delta Lloyd ordinary shares that have been repurchased is 1,182,019. The shares were bought at a weighted average price of € 14.28 per share.

The trading was done as part of the buy-back programme of 1,650,000 ordinary shares that was announced on June 10, 2010.
